**Revision of Visa, Passport and Consular Services Fee**

With effect from 1 October, 2022, Visa and Passport/consular services fee will be revised in the Embassy of India, Dakar. **Payment of fee in respect of any application made on or after 01.10.2022 should be as per revised fee structure.** Applicants are requested to go through below mentioned table containing the fee for various services and pay the fee accordingly to avoid any inconvenience.

2. It is also observed that some applicants apply for services in several days/months after depositing the fee. The Embassy has been facing issues in tracing of fee and accounting of such applications. The Audit Team has also adversely remarked upon such kind of exercise. **Therefore, application for any service in the Embassy should be made within 5 working days of the deposit of fees in the bank from now onwards.**

**(28) TRANSFER OF VISA:**

When an Indian visa affixed on an old passport is transferred to a new one, a service fee of US\$ 5 or FCFA 3300/- should be charged. This fee should not be charged from the nationals of the countries mentioned as: Afghanistan, Argentina, Bangladesh, Jamaica, Maldives, Mauritius, Mongolia, Democratic People's Republic of Korea, South Africa, Uruguay, Nepal, Bhutan and Pakistan.

**(29) RESTRICTED/PROTECTED AREAS PERMIT:**

A fee of FCFA US\$ 30 or FCFA 19,600/- introduced in March, 2000 for issuing restricted/protected area permit should not be charged from the nationals of the countries mentioned at Sl. No. 15, 30 and 32..

**(30) VISA IS ISSUED GRATIS TO THE FOLLOWING NATIONALS:**

Afghanistan, Argentina, Bangladesh, Jamaica, Maldives, Mauritius, Mongolia, Democratic People's Republic of Korea, South Africa and Uruguay. In respect of Seychelles nationals, all types of visas except for work/employment

may be issued on gratis basis (conveyed vide Ministry's circular E-mail message dated 01 April, 2015.)

**(31) Additional Fees**

- (i) **ICWF Fee (obligatory):-** Additional fee of **FCFA 2000/-** is charged by the Indian Government for each visa application in order to provide funding for the Indian Community Welfare Fund (ICWF)

**(\* Employment and Business visas to the nationals of Senegal, The Gambia and Guinea Bissau will be issued gratis subject to usual checks and submission of requisite documents. However, the Indian Community Welfare Fund (ICWF) will continue to be charged from Business and Employment Visa applicants.**

**(32) No visa is required for the following nationals :**

- (i) Bhutan and (ii) Nepal**
